

TERMS & CONDITIONS

Skin Transformation Charity Giveaway

1. Promoter Information

2. Eligibility

- Entrants must be **aged 30 or over** at the date of entry.
- Entrants must be able to attend regular treatments at The Secret Garden Clinic in Winchester.
- Entrants must be **available to attend treatment appointments** as mutually agreed with the Promoter.
- Employees, contractors, and immediate family members of the Promoter are **not eligible** to enter.

3. Entry Period

The Competition opens on **22/10/25** and closes at **11:59 PM GMT on 31/12/2025**. Entries received after the closing date will not be accepted.

4. How to Enter

- Entrants must follow the instructions provided on The Secret Garden's website.
- This includes **submitting a short application form** explaining why they or their nominee are suitable for the programme.
- **A £10 donation** is necessary to enter or win of which 100% received by The Secret Garden after processing/transaction fees will be donated to 2 local charities (The Winchester Cancer Sanctuary and Naomi House and Jacksplace)

5. Prize Details

- The winner will receive a **comprehensive skin transformation plan** valued at **over £2,000**, including a tailored package of professional treatments and consultations as determined by the Promoter.
- The exact treatment plan will be created following a **personal consultation and suitability assessment**.
- The prize is **non-transferable**, has **no cash alternative**, and cannot be substituted by the winner.
- The Promoter reserves the right to replace any part of the prize with an alternative of equal or greater value if circumstances beyond its control make it necessary to do so.

6. Winner Selection and Notification

- The winner will be selected by the Promoter and its selected charities from eligible entries based on their suitability for the programme.

- The winner will **email** within **14; days** of the closing date.
- If the winner does not respond within **5 days**, the Promoter reserves the right to select an alternative winner.
- The Promoter's decision is **final** and no correspondence will be entered into.

7. Treatment Commitment

- The winner must be **able to attend and commit to all treatments** as mutually agreed.
- Failure to attend appointments without reasonable notice may result in forfeiture of the prize.
- All treatments are subject to **medical suitability and consultation**. If the winner is not medically suitable for any treatment, a suitable alternative may be offered at the Promoter's discretion.
- **Once the treatment plan is confirmed, the clinic's standard Terms and Conditions of attendance, record keeping, cancellation, and conduct policies will apply** as they do for all clients.

8. Media and Publicity Consent

- By entering, entrants agree that if selected as the winner, they will:
 - Participate in **photography and/or videography** documenting their transformation journey.
 - Permit the Promoter to use their **before and after images, testimonials, and related content** for marketing, PR, and promotional purposes (including social media, website, and print) without further payment.
- The winner will be required to **sign a consent form** before starting their plan.

9. Data Protection

- Personal data collected will be processed in accordance with the Promoter's **Privacy Policy** and the UK **Data Protection Act 2018** and **GDPR**.
- Entrants' data will be used solely for the administration of the Competition and will not be shared with third parties unless required by law.

10. Liability

- The Promoter accepts no responsibility for entries that are lost, misdirected, delayed, or incomplete due to technical or other issues.
- The Promoter shall not be liable for any injury, loss, or damage resulting directly or indirectly from the winner's acceptance or use of the prize, except where caused by the Promoter's negligence.

11. Disqualification

The Promoter reserves the right to disqualify any entrant who:

- Breaches these Terms & Conditions;
- Provides false information; or
- Acts in a manner that may bring the Promoter or the Competition into disrepute.

12. Modification or Cancellation

The Promoter reserves the right to **amend, suspend, or cancel** the Competition at any time without prior notice if circumstances arise outside its control.

13. Governing Law
